Examined the report of speciality of the Financial, Accounting, Taxes and Local Taxes Office no. 6131/2014, regarding the resignation from the mandate of representative of the local council of Alexandru cel Bun in the general assembly of S.C. „SERV COM ALBUN” S.R.L- associated with the Municipality of Alexandru cel Bun, of Mr. Rotariu Mihai and Nicoară Cătălin - Daniel, the approval report of the Mayor regarding the project of decision no. 6131 of 24.07.2014 and the opinion of the speciality commission of the local council;

Seeing the request registered no. 5894 of 1.07.2014 of Mr. Rotariu Mihai and the request no. 6131 of 2014 of Mr. Nicoară Cătălin Daniel, by which he communicates that he resigns from the position of representative of the local council of Alexandru cel Bun in the general assembly of S.C. „SERV COM ALBUN” S.R.L- associated with the Municipality of Alexandru cel Bun.

In accordance with the provisions of art. 8 of the Representation Contract no. 5931 of 09.07.2012 regarding the resignation of the representative.

In accordance with the provisions of art. 36 (3) lit. „c,” and art. 45 (1) of Law no. 215/2001 regarding local public administration, republished, with subsequent modifications and completions;

HOTĂRĂȘTE:

Art. 1. Starting from the date of August 1, 2014, the mandates of representation of the local council of Alexandru cel Bun in the general assembly of S.C. „SERV COM ALBUN” S.R.L- associated with the Municipality of Alexandru cel Bun, of Mr. Rotariu Mihai and Nicoară Cătălin - Daniel, are resigned from the mandate in accordance with art. 8 of the representation contracts no. 5931 of 09.07.2012.

In a term of 10 days, Mr. Rotariu Mihai and Nicoară Cătălin - Daniel will present to the local council of Alexandru cel Bun a written report regarding the activity performed in the position of representative of the local council of Alexandru cel Bun in the general assembly of S.C. „SERV COM ALBUN” S.R.L- associated with the Municipality of Alexandru cel Bun, in the period 09.07.2012- 1.08.2014.

Art. 2. The Mayor of the Municipality will communicate the present decision to the authorities and interested parties and will make it public through posting at the town hall.
